STATE OF INNOVATION CHALLENGE: CAN STUDENTS HELP OUR STATE?

Teachers, youth development programs, clubs, and community-based organizations are invited to connect the youth they serve with an opportunity to design solutions to the problems of today, and explore the careers of tomorrow. Launched in November, Washington middle and high school students are being asked to find a better way to get surplus food to people experiencing food insecurity, and create new ideas on how teenagers can stay mentally healthy while social distancing, among other challenges. WASHINGTON HEALTH SENTINEL NETWORK RELEASES KEY FINDINGS

Washington's Health Workforce Sentinel Network, which captures key recruitment, retention, and skills issues being confronted by healthcare providers, including during the COVID-19 pandemic, has released findings from the most recent study. Fewer Washington healthcare employers are reporting problems obtaining PPE, than findings collected in the spring. However, issues that existed before the pandemic, including attracting healthcare workers to rural areas, and the need for more nursing assistants, medical assistants, and dental hygienists, have been exacerbated by the pandemic. FOOD SUPPORT FOR COLLEGE STUDENTS ARRIVES DURING PANDEMIC

As COVID-19 worsens hunger for college students across the United States, thousands more community and technical college students in Washington state will receive food benefits. The U.S. Department of Agriculture recently approved Washington's proposal to allow low-income students in a wider range of certificate, degree, and industry-recognized programs to receive food assistance through the state's Basic Food Employment and Training Program, or BFET, provided they meet all other eligibility criteria. Previously, this support was available only to income-eligible students enrolled in vocational programs or basic skills classes. Once students qualify for food assistance and enroll in the BFET program, they receive other benefits like tuition assistance, jobsearch services, and financial help for basic needs like school supplies, books, child care, housing, utilities, medical bills, and clothing. NEW REPORT SHOWS HALF-MILLION CHILDREN WITHOUT ACCESS TO LICENSED CHILDCARE

Before the pandemic, over half-a-million children in Washington did not have access to licensed child care, and nearly one in five parents surveyed turned down a job offer or promotion due to child care issues, according to a detailed Child Care Industry Assessment Report released by the state's Department of Commerce this week. The assessment includes an important analysis of the current state during the pandemic, and how the industry has changed since the beginning of 2020. RETAIN WASHINGTON SEEKS INJURED WORKERS FOR RESEARCH STUDY

A return-to-work program in King, Pierce, and Snohomish counties, funded by the U.S. Department of Labor, is making support available to help injured workers receive the health and wellness assistance and employment resources they need to continue working. RETAIN Washington's program focuses on early coordination of services for injured or ill individuals. The organization is recruiting up to 250 candidates through September 30 of this year to participate in a pilot research study that measures whether certain interventions, including case management, can help those with injuries or disabilities stay on the job or return to work. WA HEALTH WORKFORCE DATA SHOW INITIAL UNEMPLOYMENT CLAIMS MAY HAVE PEAKED

The University of Washington Center for Health Workforce Studies has been tracking initial unemployment claims in Washington on a weekly basis using data from the Washington State Employment Security Department and with the support of the state's Workforce Board. The analysis to date suggests we have passed the peak of initial healthcare unemployment claims, with large job loss among oral health workers given that most dental clinics closed due to shelter-in-place orders. The Workforce Board staffs the state's Health Workforce Council, which works closely with the UW Center for Health Workforce Studies to address challenges facing our state's health workforce. WASHINGTON'S FEDERAL GRANT APPLICATION RESULTS IN \$12M FOR DISLOCATED WORKERS

Washington has been awarded a \$12 million Dislocated Worker Disaster Recovery Grant from the U.S. Department of Labor. This grant category, used most often for areas struck by natural disasters, focuses on

preparing and placing dislocated workers into "disaster clean-up and mitigation" jobs, but also allows for investments in longer-term education and training to prepare workers for more stable post-disaster employment. The state application, filed by the Employment Security Department, and developed in partnership with the state's 12 local Workforce Development Councils and the Workforce Board, requested close to \$54 million to help retrain dislocated workers for occupations that will be in-demand during the pandemic recovery. Partners are currently working on revising the project implementation within the new budget parameters.
