






NHSC Trends

- Funding has increased for the program
 - FY2021 \$800 million dollars from American Rescue
 Plan
- Record number of awards expected in the next fiscal year

Substance Use Disorder and Recovery (STAR)

- STAR Loan Repayment is a new federal program also administered by HRSA but separate than NHSC
- Key differences from NHSC:
 - <u>Eligible disciplines</u>
 - Expanded eligibility bachelors level SUD professionals, MSW, PsyD interns, and many more
 - <u>Service site types</u>
 - Site approval based on Overdose Mortality Rate or HPSA status
 - Obligation and Award Amount
 - Six years for \$250k, no half time option and award is taxable
- Do not have data on reach or impact yet.
 - No awardees in WA in FY21 and FY22 data not yet released.
